HIGHLIGHTS / ACHIEVEMENTS AGAINST PLAN

Project

1. Project Brief (updated with Success Criteria) agreed by 08/10/09 PPEB

1. All seven forces have the third quarter Candidate Tracking Sheets.

Candidate Administration

- 1. 2010 Rules and Syllabus 'signed off' at 08/10/09 PPEB.
- 2. Places to Inspectors Part II 2010 allocated in such a way that, should adopter forces achieve interim licence in time, their NPPF candidates can be removed from process by 'reducing time at the end'.

Workforce Strategy

- 1. PPEB Constitution being re-drafted to take account of changes. Target for circulation Feb 2010.
- 2. Updated Equality Impact Assessment noted by 08/10/09 PPEB.
- 3. Operating Manual 'signed off' by 08/10/09 PPEB.

Finance

1. 2010/11 NPPF budget forecast and submitted to cover the cost of trialling the NPPF to seven 'existing' and three 'adopter' forces.

RISKS / ISSUES

1. Closed Red Risk: Completion of Interim Licence is likely to take 6 to 12 months. The three adopter forces will not be able to complete all four steps of the NPPF in the available time. Mitigating Action: - NPPF Timeline Paper issued to 07/07/09 PPIPB for consideration. PPIPB to make recommendation to PPEB.

Risk Number 1 - Red Risk: The July 2009 PPIPB Provided Steer. Three adopter forces report at the stage they are at on 31/03/11 therefore no extension to the Project End Date — Risk mitigated and closed.

2. Closed Green Risk: Three forces may not be successful through the selection criteria. Mitigating factors:- Eight Expressions of interest have been received. Selection Panel meet 14/07/09. Staff available for telephone assistance to help forces.

Risk Number 2 – Green Risk: Three forces were successful. Risk closed.

3. Closed Green Risk: (now an Issue): The Met identified that they were unlikely to meet the 22/05/09 date for data capture. The consequential effects, when this risk materialised, are that the populated Met Candidate tracking was not issued from NPIA on time; the Met are behind schedule with their submissions; Met will miss the 1st 1/4 cut off date. PPEB will not have a full analysis, which may lead back into the area of concern previously expressed by stakeholders. Mitigating factor: - The Met have been given a different, later, submission date than the other six trial forces. The Met have undertaken to achieve this deadline. PPIPB are aware of this and whilst disappointed, accept the plan which is in place.

Risk Number 3 – Green Risk. Transferred to Issues Log. Risk closed.

- 4. Green Risk: At their March 2009 meeting, the PPEB agreed that A1 / V1 should be the minimum assessor and internal verification qualifications for National Police Promotion Framework. However, the Chair of the PPEB has indicated that if the accredited awarding body has been approved to issue individual unit certification by operating on a different basis than that by QCA/Ofqual, then this might be acceptable and the force should make representations to the Police Promotion Examinations Board. Mitigating Actions: Chair of PPEB has written to SFJ. The PPEB Chair met SfJ Chief Executive on 23/07/09 and proposals are being brought by SfJ to the 08/10/09 PPEB.
- 5. Closed Green Risk: Leicestershire may not be able to register with an awarding body in a short time frame relative to bringing their Sergeants into the NPPF Trial. Closing factor: Leicestershire are now adopting the NPPF Trial for their Sergeant rank in 2010. Risk Closed.
